# Terms & Conditions of Hire

## Function Area:

Barefoot Bowls & BBQ guests are welcome to use the Outdoor and General areas of the Sandgate Bowls & Community Centre and are welcome to use their designated green for the duration of the function. Please note that the green is not private as it may be used by other bookings being held at the same time.

## Prices:

Menu prices include green hire, bowls equipment hire, initial bowls tutorial and catering.

## The Outdoor Area has the following facilities:

## Tentative Bookings:

Tentative bookings are held for 2 weeks from temporary booking date. In that time a deposit of \$200.00 (or otherwise indicated in quote) and a signed copy of the Terms and Conditions is required to confirm and hold the booking. If both the deposit and the signed copy of the Terms and Condition are not received within the 2 weeks, the booking will be automatically cancelled.

## Cancellations:

21 days written notice is required of a previously confirmed booking. Refund of deposit and any partial payments is at management discretion; although deposits are usually fully refunded if the function is cancelled 21 days prior to the date booked or if the function can be resold.

## Payment:

Full payment of the food account is to be received 24 hours prior to the commencement of the function. Bar account is to be paid on the day unless prior arrangements have been made.

## Minimum Guests:

A minimum number of 20 is required for all Barefoot Bowls & BBQ functions.

## Final Numbers, Menu and Beverages:

**All final function details, including final numbers, menu selections and beverage options, are required no later than 5pm 14 days prior to the function.**

Charges will be calculated on the minimum number of people (20 as stated above) or the confirmed final number given 14 days prior, whichever is greater.

## Children's Pricing for Catering:

Children under 3 years are free, 3 to 12 years are half the menu price and children over 12 years are full price.

## Children's Supervision:

Children must be strictly supervised at all times by a parent or guardian. Children under 12 years old are not permitted to play bowls.

## Available Days:

Evening Barefoot Bowls and BBQ functions can be held on Tuesday, Wednesday, Thursday, Friday and Saturday nights, subject to availability. Daytime Barefoot Bowls and BBQ functions can be held on Sunday afternoons and various other days, subject to availability.

### **Catering Times:**

Our chefs will cater for your Daytime BBQ between 12mid to 1.30pm and Evening BBQ between 5.30pm to 7.30pm.

### **Bowls/Function Times:**

Evening Barefoot Bowls & BBQ functions generally start at 5pm. The lights on the greens will be turned off at 9pm nightly, and the BBQ area is to be entirely vacated by 10pm Tuesday, Wednesday and Thursday, or by 11pm on Friday and Saturday nights. Sunday Afternoon Barefoot Bowls & BBQ's generally start at 12mid, and the BBQ area must be entirely vacated by 5pm.

### **Outdoor Bar:**

Functions of more than 50 may request the Outdoor Bar to be opened at no additional charge. Limited beverages will be available in the Outdoor Bar, a full range of beverages will be available from the Main Bar indoors.

### **21st Birthday and Special Functions:**

A \$500.00 bond is required for 21st birthday functions, and may be required for other function bookings at Management's discretion. Any damages or excessive cleaning costs will be assessed and the cost deducted from the bond. Credit card details must be held for security.

### **Sunday/Public Holiday Functions:**

Functions held on a Sunday or Public Holiday will incur a 10% surcharge

### **Non-Bowlers:**

No reduction on the cost of the menu will be given to guests who do not wish to play bowls.

### **Sign In:**

Guests attending a function may not play gaming machines unless they have signed in as a member of Sandgate RSL Club or as a reciprocal member of another club or a guest that lives 15 km away from Sandgate RSL Club.

### **Food:**

No foodstuffs may enter or leave the club.

### **Dress Regulations:**

Dress rules apply, contact club for details.

### **Footwear:**

White soled shoes are permitted on the Bowling Greens, or function guests can play bowls barefoot, how-ever footwear must be worn into the Club at all times. Rubber thongs can be worn into the Club before 6pm if function guests use the toilets or purchase beverages at the Bar, however proper slip on shoes or dress shoes are required after 6pm.

### **Weather:**

In the event of bad weather, if the greens are deemed to be unsuitable for play, the following options are available:

If space permits, the function may still proceed with the BBQ indoors and a \$5ph reduction in the cost of the menu will be given due to not being able to play bowls. A full refund will be offered if we are unable to accommodate the function indoors.

The function may choose to reschedule for another suitable date.

The function may cancel and receive a full refund of the deposit and any partial payments.

If the greens are deemed fit for play, no refund or reduction in cost will be given if the function chooses not to proceed.

### **Damages:**

Sandgate Bowls & Community Centre will not accept responsibility for any damage or loss of merchandise incurred during the function. Wilful damages and breakages are not covered in the menu prices. Damages must be paid for by the individual, group or company holding the function.

### **Cleaning:**

Table scatters, confetti, glitter and rice is not permitted in any area of the Club. A charge may be incurred for removal of such items.

### **Smoking:**

Under the Tobacco and Other Smoking Products Amendment Bill 2004 smoking is not permitted inside the Club house. Smoking is permitted in the Designated Outdoor Smoking Areas. Please refer to venue signage for details.

### **Privacy:**

While we make every effort to ensure your function is not disturbed by other functions or the general club noise, please note that the function will be held in the general area of the Club and therefore may not be completely private.

### **Alcohol:**

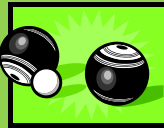
The liquor act 1992 provides for severe penalties associated with underage drinking. An individual may be asked for current photo I.D. if consuming alcohol.
